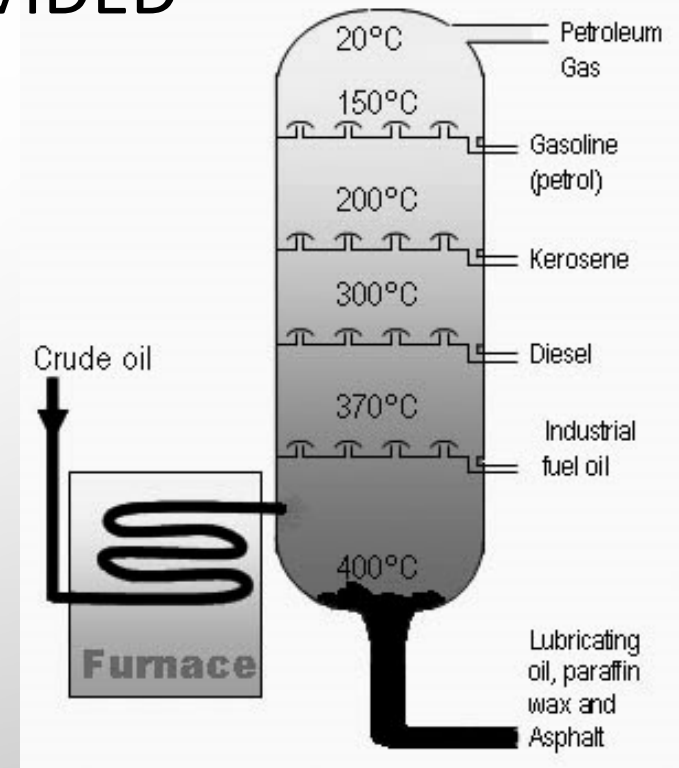
# INCORPORATED

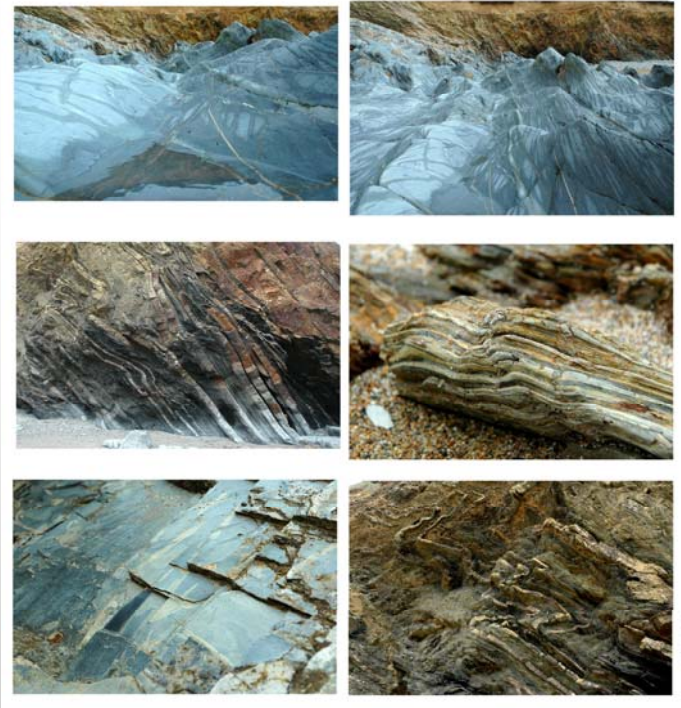


# RESERVOIR ENGINEERING

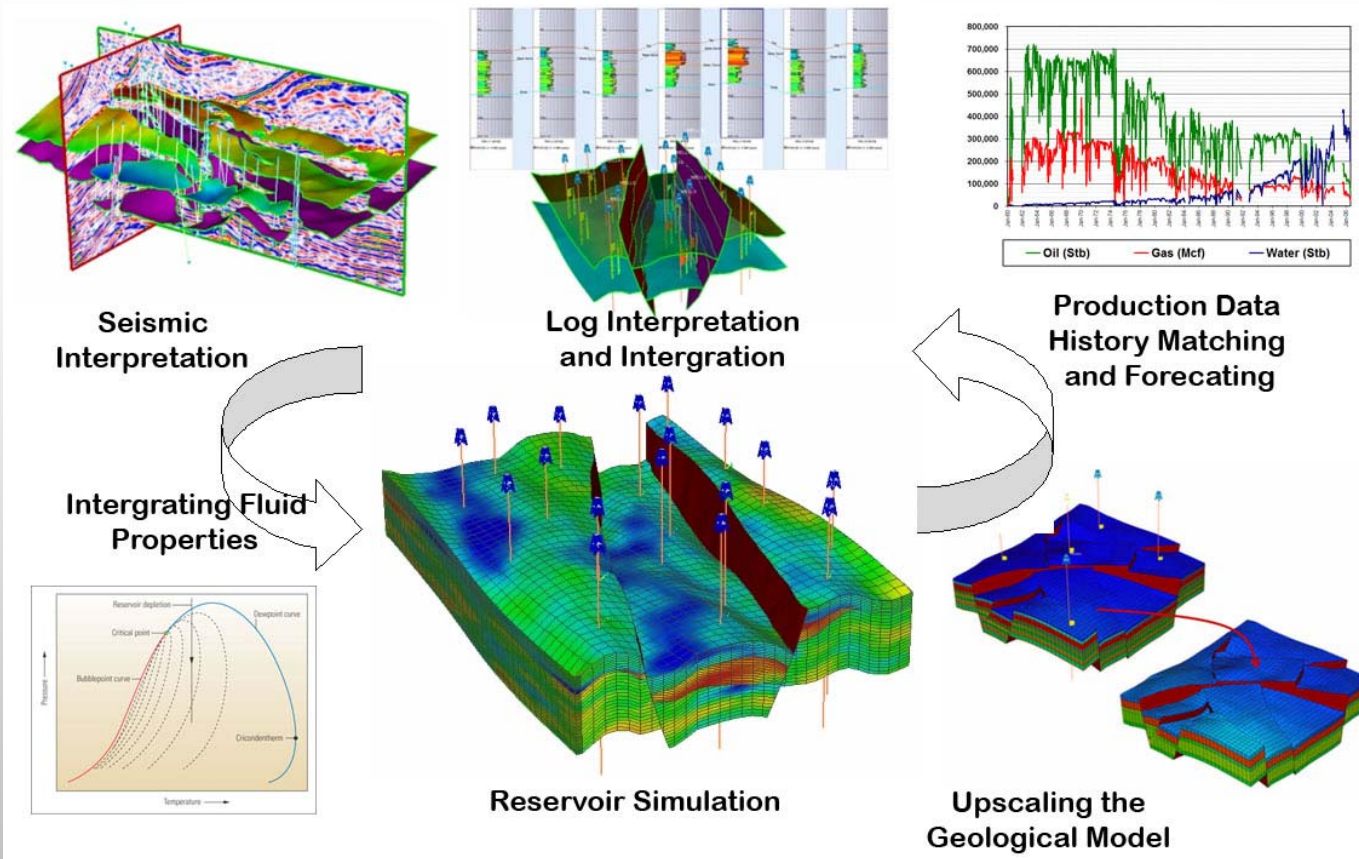
